# Maple Ridge Archery Codes of Conduct COACHES - VOLUNTEERS - ATHLETES

### ATHLETES CODE OF CONDUCT

In registering as an Athlete member (all types) of Maple Ridge Archery and within the context of the activities of Archery an individual agrees to take part in a spirit of fair play, honesty and with the rules and regulations of Maple Ridge Archery, BC Archery and Archery Canada. As such the Athlete member is expected to:

- 1. Compete/participate in a spirit of fair play and honesty.
- 2. Compete/participate within the rules of Archery.
- 3. Refrain from using alcohol, banned substances and tobacco products at athletic events (Archery and other sport activities) or in victory celebrations at the competition site.
- 4. Refrain from using profane, insulting, harassing or otherwise offensive language or wearing offensive clothing in the context of the activities of Archery.
- 5. Address fellow athletes, coaches, officials, volunteers, event organizers, spectators and others associated with Archery in a courteous and respectful manner.
- 6. Act in a manner that will bring credit to the Archery Community and yourself, both within and outside the competition arena and/or competition area.
- 7. Respect an individuals' dignity; verbal or physical behaviours that constitute harassment or abuse are unacceptable. (Please refer to the BC Archery Harassment Policy)
- 8. Ensure the safety of others when taking part in your Archery activity.

### **COACHES and VOLUNTEERS HAVE A RESPONSIBILITY TO:**

- 1. Treat everyone fairly within the context of Archery, regardless of gender, place of origin, colour, sexual orientation, religion, political belief or economic status.
- 2. Direct comments or criticism at the performance rather than the athlete.
- 3. Consistently display high personal standards and project a favourable image of Archery and of Coaching:
  - a. Refrain from public criticism of fellow coaches and volunteers
  - b. Refrain from the use of profane, insulting, harassing or otherwise offensive language in the conduct of your coaching or volunteer duties.
- 4. Ensure that the activity being undertaken is suitable for the age, experience, ability and fitness level of the athletes and educate athletes as to their responsibilities in contributing to a safe environment.
- 5. Treat fellow coaches, volunteers, athletes you do not coach and officials with due respect, both in victory and defeat and encourage athletes to act accordingly. Actively encourage athletes to uphold the rules of Archery and the spirit of such rules.
- 6. In the case of minors, communicate and cooperate with the athlete's parents or legal guardians, involving them in management decisions pertaining to their child's development.
- 7. Be aware of the academic pressures placed on student-athletes and conduct practices and participation in competitions in a manner so as to allow academic success.

Individuals registering as Athletes or Coach members of Maple Ridge Archery are advised that by joining Maple Ridge Archery they are agreeing to adhere to this and other policies, rules, regulations, by-laws and constitution of Maple Ridge Archery, BC Archery, and Archery Canada.
